



TERMS AND CONDITIONS OF THE WTC BARCELONA CHRISTMAS PRIZE DRAW **2018**

1.- World Trade Center Barcelona, SA

The organisation of this PRIZE DRAW is the sole responsibility of World Trade Center Barcelona SA, with registered offices at Moll de Barcelona s/n Edifici Est, 1a planta, 08039 Barcelona, tax identification code (CIF) A-59390948, hereinafter "WTC Barcelona".

2.- Purpose and rules of the PRIZE DRAW

Said PRIZE DRAW will be held through the <https://www.random.org/> website, where the number of official participants will be entered and the winners chosen randomly on the basis of web algorithm.

PRIZE DRAW 1+ will be drawn from the database generated by the electronic application form signed by the participants, with the holder of the 1st winning ticket (Winner 1+) or the person substituting them (Reserve 1+), as the case may be, being entitled to claim the prize, consisting of a one-night stay at the Hotel Spa Empúries for two people and an experience for them to select.

PRIZE DRAW 2+ will be drawn from the database generated by the electronic application form signed by the participants, which will generate a virtual numbered ticket, with the holder of the 2nd winning ticket (Winner 2+) or the person substituting them (Reserve 2+), as the case may be, being entitled to claim the prize consisting of a case of 6 bottles of Cava.

PRIZE DRAW 3+ will be drawn from the database generated by the electronic application form signed by the participants, which will generate a virtual numbered ticket, with the holder of the 3rd winning ticket (Winner 2+) or the person substituting them (Reserve 3+), as the case may be, being entitled to claim the prize consisting of a case of 6 bottles of Cava.
