



## **WTC BARCELONA CHRISTMAS PRIZE DRAW 2017 TERMS AND CONDITIONS**

### **1.- World Trade Center Barcelona, SA**

This organisation of this PRIZE DRAW is the sole responsibility of World Trade Center Barcelona SA, with registered offices at Moll de Barcelona s/n Edifici Est, 1a planta, 08039 Barcelona, tax identification code (CIF) A-59390948, hereinafter "WTC Barcelona".

### **2.-Purpose and rules of the PRIZE DRAW**

The purpose of this PRIZE DRAW is to select three WINNERS from the participants of the "#ILUSIONWTCB" Christmas event organised in WTC Barcelona on 18, 19 and 20 December 2017.

"PRIZE 1" will be drawn from the numbered tickets held by the participants, with the holder of the 1st winning ticket ("Winner 1") or the person substituting them ("Reserve 1"), as the case may be, being entitled to claim the the prize consisting of a two-night stay at the Hotel Les Hamaques and a meal for two people at the Molí de l'Escala.

"PRIZE 2" will be drawn from the numbered tickets held by the participants, with the holder of the 2nd winning ticket ("Winner 2") or the person substituting them ("Reserve 2"), as the case may be, being entitled to claim the prize consisting of a case of 6 bottles of Cava.

"PRIZE 3" will be drawn from the numbered tickets held by the participants, with the holder of the 3rd winning ticket ("Winner 3") or the person substituting them, as the case may be ("Reserve 3"), being entitled to claim the prize consisting of a case of 6 bottles of Cava.

The winners' names will be published on the 22 December 2017 (“Winner 1”, “Winner 2” and “Winner 3”) through WTC Barcelona's social media. The winner will subsequently be notified via the telephone number shown on the ticket. The winners will also be announced in the first edition of the WTC Barcelona 2018 e-news.

In the event it has not been possible to contact the winner ten working days after the PRIZE DRAW has been held (Wednesday 10 January 2018), the prize will be awarded to the substitute ticket holder (“Reserve 1”, “Reserve 2” and “Reserve 3”). If the reserve ticket holder has not been located 15 working days after the PRIZE DRAW has been held (Wednesday 17 January 2018), the prize shall be declared null and void.

### **4.- Prizes**
